On July 1, 2014, payment for Community First Choice providers will increase. Rates will increase by 2.5 percent based on the Medical Assistance Program's budget for Fiscal Year 2015.

Attached is a list of revised rates for Fiscal Year 2015. Providers may bill the new rates for services provided on or after July 1, 2014.
